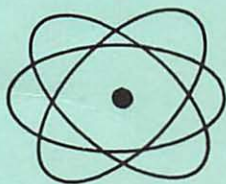
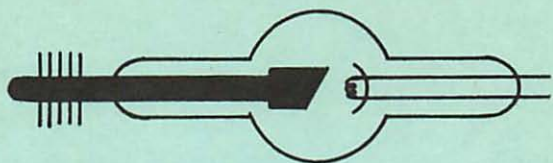

ABSTRACT OF MINUTES
MEETING OF BOARD OF DIRECTORS
June 16, 1973

The regular quarterly meeting of the MSRT Board of Directors was held on Saturday, June 16, 1973, at the Holiday Inn, Lake of the Ozarks. This was an excellent opportunity to view the facilities for the annual MSRT Convention scheduled to be held there during the first week of October.

In the absence of Ellen Clements, Secretary, the minutes were recorded by Sr. Francita. The meeting was called to order at 10:50 A.M. by Phyllis McEnerney, President.

----CALIFORNIA PROPOSAL: A letter was read from James Mom, R.T. of the California Society asking for support at the ASRT meeting on a proposal to permit 2nd year students to vote in state affiliated societies.

After discussion of this issue, Mr. Rein moved that in the event the proposal passed at the national meeting, the MSRT membership vote on the issue so that, if approved, the change could go into effect immediately if ratified by the mail vote of ASRT. Motion carried.

----ANNUAL CONVENTION REPORT: Michael McMaster accepted the appointment as General Chairman to replace Jim Francis who had resigned. Suzanne Hasler reported that all convention committees are organized and working. Progress reports were reviewed and fees for registration approved.

----RESOLUTIONS AND BYLAWS: The committee reported several changes which

will be presented to the membership for consideration. Namely: to combine the office of Secretary and Treasurer; to elect the Secty-Treas. for a two year term; and an increase of dues.

----STUDENT COMMITTEE: Terry Karch reported that the Student Committee met in February and April with another meeting scheduled in two weeks. Several students had offered to assist on various convention committees but have not been given assignments. A list of these student volunteers was again given to the new general chairman of the convention.

----LICENSURE COMMITTEE: Gerald Casey presented a written report on HB 314 which was placed on file. David Blackwell suggested that the feeling of the membership should be ascertained at the time of the convention so that the Board will have some specific direction for action during the coming year.

----CONVENTION CITY REPORT: Merlin Heinselman reported that all districts have been contacted and asked to consider hosting the convention for 1974 or 1975. He is awaiting replies.

----NATIONAL ECONOMICS COUNCIL: A communication from ASRT was read giving some details on NEC. Mr. Rein moved that the information be referred to the Professional Affairs Committee for further study and to submit it for publication in the manner they think advisable. Motion carried.

----DISTRICT REPRESENTATIVES: Each district representative was asked to notify the President, Miss McEnerney, of the

name of the new district representative as soon as possible.

----4th District Resolution: Marty Strussion stated that the members of the 4th District wished to voice a strong opposition to the decision of the Board made at the April 5th meeting to ban tape recordings of the meetings.

The next meeting will be held on Wednesday, October 3, 1973. The meeting adjourned at 4:40 P.M.

1. PRIZES: R.T. & Student Category

First Award:	\$50.00
Second award:	\$25.00
Third Award:	\$15.00

2. **ELIGIBILITY:** All members in good standing of the affiliate society are eligible to compete for awards. (The following members may not participate in competition: President, Gen.Chmn.of convention, Exhibit Chmn, exhibit judges, or persons employed by commercial firms engaged in the sale or manufacture of x ray products.
3. **JUDGING:** The three judges shall be selected by the President and will be responsible only to the President. The judges' selections shall be based upon the rating listed in the Exhibit Judging Evaluation Scale.
4. **APPLICATION FOR SPACE:** (A.) All applications for space shall be postmarked by the deadline date of 9-17-73. (B.) The total space allotted for any one exhibit shall not exceed eight (8) 14 X 17 inch viewing spaces.

SUBJECT MATTER:

- A. Exhibits must be thw work of the individual technologist/s and be shown in their name. The name of the hospital or office may appear as part of their address.
- B. The exhibit should consist of a subject pertaining to radiologic technology supplemented by such charts, photographs, technical factors, etc. as deemed necessary.
- C. The exhibitor must remove or block out markings on the film in such manner

that no identification of the patient is possible.

- D. Exhibits will not be considered for award if they have been displayed at any radiological meetings (ACR, RSNA, AMA, Etc.). However, they may be displayed on a non-competitive basis.

Exhibits entered for competition must be set up by Thursday noon and taken down between 12:00 noon and 6:00 P.M. Saturday.
