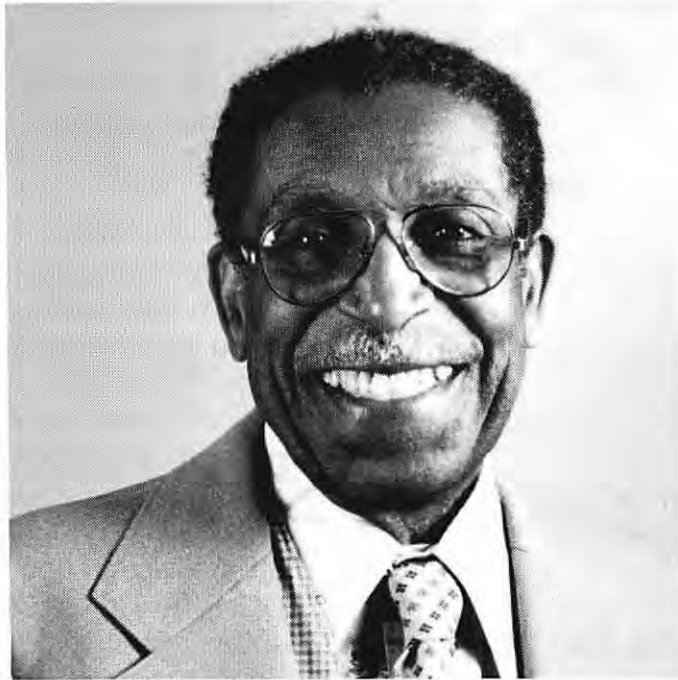

## LECTURE NAMED FOR ULYSSES D. MURRAY, R.T.



The Missouri Society of Radiologic Technologists named an invited lectureship for Ulysses D. Murray, R.T. during the 1986 MSRT Annual Meeting at Osage Beach, Mo.

Mr. Murray was born in Hattiesburg, Mississippi and moved to St. Louis when he was in the second grade. After graduation from high school he attended Stowe Teachers' College & St. Louis University. He received a certificate in hospital administration from St. Louis University in 1957.

His interest in x-ray began during his Navy career during World War II. After his discharge from the Navy he entered Homer Phillips School of X-Ray Technology graduating with the first class. He was registered by the ARXT in January 1949, joining the ASXT the same year. He joined the MSRT in 1950.

Since joining the MSRT he has served as President, vice-president, secretary, chaired many committees and chaired Annual Meetings. He was associate editor of "The Missouri Minutes" and served as the

Mr. Murray was the first Region V ASRT Regional Director. He served ASRT as General Convention Chairman in 1967, as a counselor for Missouri and as chairman of the Resolutions and Bylaws Committee in 1970.

Mr. Murray has won Exhibit awards on the state level, in 1954 a 1st place for "Cerebral Angiography" and a 3rd in 1957 for "Zygoma". He is a published author and has presented many lectures for the MSRT during our annual meetings.

His interests, other than radiography, are varied and include active membership in the Midwest-Gateway Chapter and the American Institute of Parliamentarians. He is also an avid professional wrestling fan.

The MSRT membership knows Mr. Murray as the dedicated professional technologist he is, and we are honored to have had him as a long standing member of the Missouri Society of Radiologic Technologists. We look forward to many more years of his guidance and able leadership.

After breakfast Ms. Laura Steiner representing the Breckenridge-on-the-Lake welcomed the MSRT. A welcome address was given by Convention Chairman James L. Watson. Norman L. Hente, ASRT Region V Regional Director welcomed us in behalf of the ASRT.

The Annual Meeting Rules were read by Secretary Lee Ann Ackerman and were adopted by the membership.

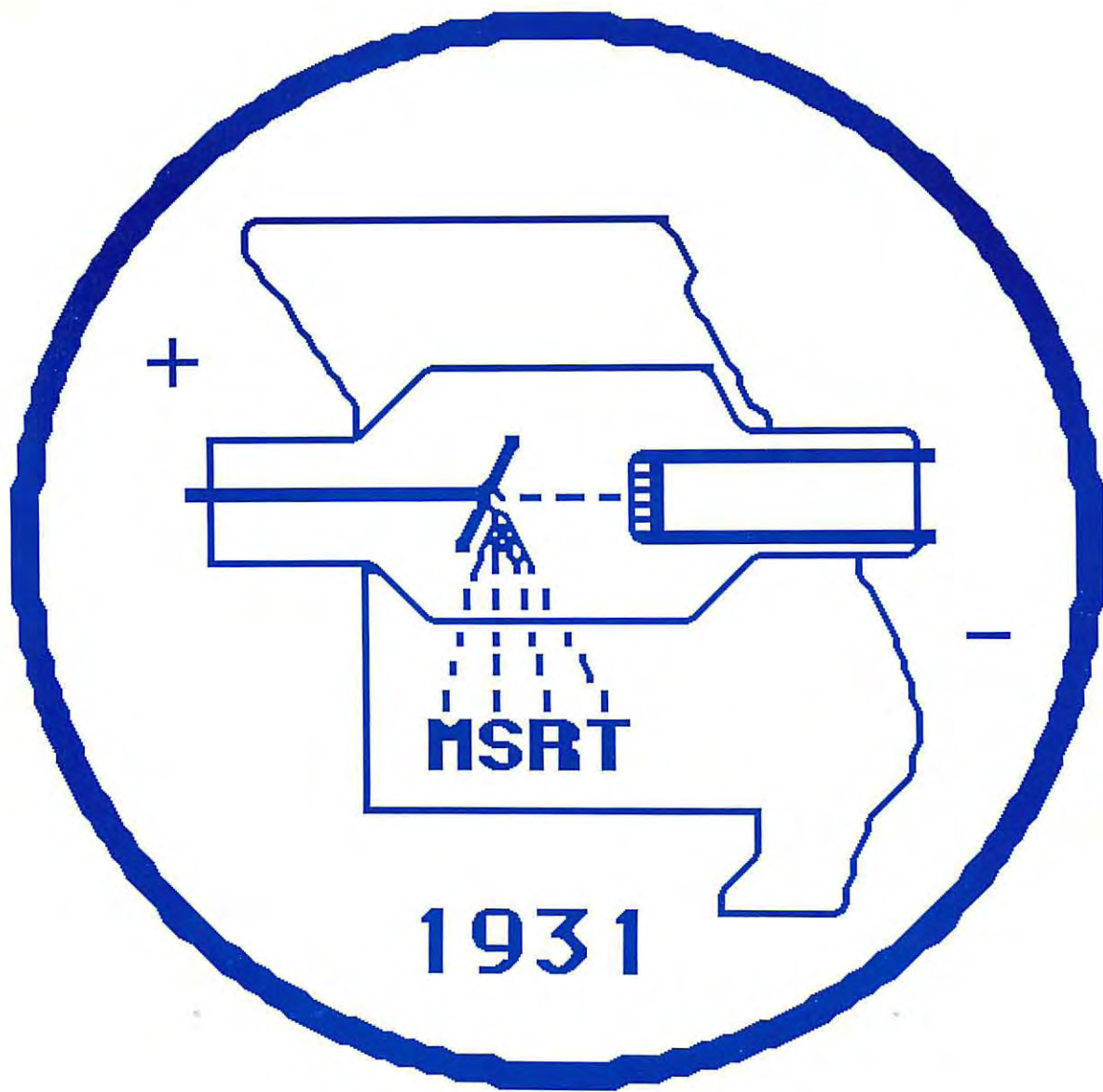
