

LEGISLATIVE UPDATE

Senate Bill 671, sponsored by Senator Joseph Mosely, was passed out of the Senate Public Health and Welfare Committee on March 7. It now moves on to the full Senate for consideration.

Donita Shipman, MSRT Secretary, is organizing a "lobby day" in conjunction with scheduled floor debate of the bill in the Senate.
